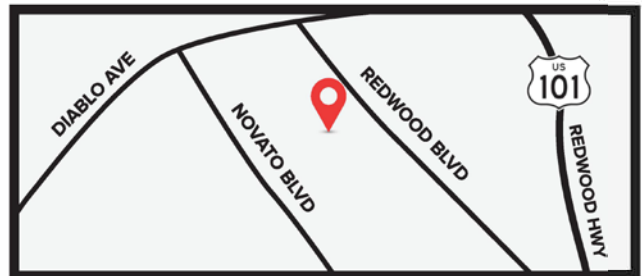
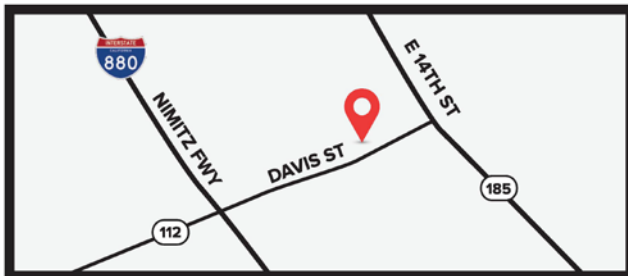

AMERICA'S OLDEST CORVETTE CLUB

In July of 1956 in the East Bay, two Corvette owners, Johnny Zeh and Jerry Wright, waved & stopped to talk. Corvettes were few in numbers then and several weeks could pass before encountering another. These drivers discussed starting a Corvette Club.

By July 15, 1956, an informal meeting of Corvette owners decided to establish the Northern California Corvette Association. These early Corvette Owners met frequently at each other's homes with their numbers increasing each month.

On March 28, 1957, an initial group of 35 met at Daily Chevrolet in Oakland to establish the Bylaw's. By then Josh Hogue, San Francisco Examiner's sports car event columnist suggested that this group combine with the one meeting at Les Vogel Chevrolet in San Francisco.

On May 9, 1957, NCCA was incorporated, and 40 members elected Roy Storey President. Roy was a TV and radio sportscaster and Corvette participant in SCCA's regional races. Sandy Greenbalt was elected Vice President, Patty Gellenbeck, Secretary and Jon Zeh, Treasurer. The charter membership for NCCA was closed at the of May 1957 listing 47 members.

President Roy Storey suggested a series of autocross events named after Grand Prix races. NCCA presented Northern California's 3rd autocross. 150 cars drove the course at the Milpitas Ford Plant. This series set the standard for autocrossing in Northern California. Though Roy Storey was soon transferred to Hollywood by CBS, he helped NCCA to properly start as a competing club.

NCCA still participates in autocrossing, drag races, track racing and car shows sponsored by many surrounding clubs. We have evolved into more of a social club over the years with focus on day and weekend trips. In recent years autocrossing interest has decreased. In July 2022, NCCA joined NCCC, National Corvette Club Council, Inc., offering numerous types of sanctioned competition events across the nation and much more.

NCCA celebrated its 50th anniversary in 2007 by inviting past presidents to a dinner dance where we shared memorabilia. Our calendar is filled each January with events for the coming year that include trips to an assortment of locations, car shows, our annual fall banquet, and Christmas party.

The club's signature annual event, **Vette Magic Car Show**, has traditionally been a two-

day, all Corvette Car Show and Drag races. It was sponsored and organized by NCCA each summer. In 2015, for the first time, in a major break with tradition, Drag Races for the **40th Vette Magic** were opened to all BOWTIE (Chevrolet) and in 2016 for 41st, to all GM sedans and sports cars. The last Car Show and Drags format was hosted in 2018. We continue the tradition of the Car Show held at The Blackhawk Museum in Danville each year. Legend on Display Car Show is held in early spring. These events continue to draw many Corvette enthusiasts and spectators from Northern California and the surrounding states.

NCCA is a valuable member of our community, as we contribute to several charitable organizations each year through our charitable foundation.

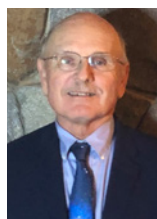

General Business Meeting Minutes

Shirley Smith, Secretary

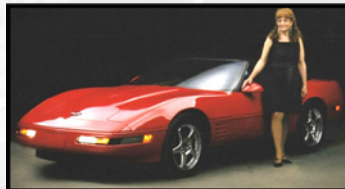
Call meeting to order at 7:00 PM

Roll Call of Members - 17 in attendance.

President: Rob Andersen

Welcome members.

We have one guest this evening – Jim Watson from San Jose, who has a Z06.



A motion was made to approve the minutes in last month's K and all approved. I appreciate everyone showing up tonight. I want to go through each of our offices to discuss where we are at month.

I am passing out information on what has most recently happened with the club. This information was discovered on Oct. 20, 2022. We will talk about where we are at and what is going on.

Mary Coon brought this to my attention. She was looking for our 501c3 copy of documents and she found out online that our status with the IRS had been revoked. We were automatically revoked for not filing a 990-N form online for 3 years in a row.

Rob - Our club is a 501C7 (Social Club) this category is what has been revoked. (Please note: NCCA in the past had a 501c3 status with the IRS - NCCA Charitable Foundation with a EIN # which was terminated in Nov. 2008).

NCCA was granted a 501c7 –Social Club EIN Number in February 1994.

Rob & Tim – We need a tax attorney to help us with reinstating our 501c7 status. Tim suggested an attorney that specializes in handling reinstatement of Club status with the IRS.

Rob - Ken & Mary have done extensive research and contacted the IRS and spoke with an agent to gather information on how to get us reinstated.

Rob made a motion to hire an attorney. It was seconded and all in attendance at the meeting were in favor of acquiring an attorney.

Herb – Made a suggestion to get a tax preparer on an annual basis to do this paperwork for us. Then there will be someone on the outside that will do this annually and the club will pay for their service. I have a tax guy I have used for many years in San Lorenzo, I can send Shirley his contact information.

Rob – Motion to talk to a tax person to help us with our taxes and steps to take to clear this up. Motion was seconded and all members present were in favor.

We need to vote on the new EBoard members at tonight's meeting. We have someone to take on the Social Director position. New members, Shawn and Cori Jonas. No one else is willing to take on social.

Rob - I ask for a vote from all the members present to have Shawn and Cori Jonas take the position of Social Directors. All in favor – Everyone! No one opposed.

President – Rob Andersen – My position as President, I accepted yes for another year.
Secretary position – Shirley Smith – stays the same
VP Events – Mary Coon – stays the same
Membership – Ken Coon – stays the same
Charitable – Hal & Madeline Briar – stays the same
Historian – Herb Clore – stays the same
BMAL – Tim Sullivan agreed to one more year.
Treasurer – George Robinson has handed in a resignation letter tonight.

Harvey Grasso has spoken up tonight and is willing to volunteer to take over the Treasurer position. Harvey has been accepted by all present to take over the Treasurer position.

NCCC: Rob Andersen – Nothing to Report

I will contact the president of NCCC to see if they have anyone that can help us with our issue with the IRS.

VP Events/Motorsports: Mary Coon

I spoke to Tianna over at San Andreas EA Services, they are having a Christmas Open

House on Tuesday, Dec. 20, 2022. They will host an Open House where parents pick up gifts for their kids between 9am to 5pm. So, we as a club will not have anything officially planned with them this year. As far as donations, they have a total of 17 kids in their program. What we did last year was give them each gift cards for \$35.00. If everyone wants to still do this lets vote.

Rob -we should keep it the same.

Per Mary - I will place gift card orders with Walmart again. Is this approved? Motion made. Yes, all approved to give \$35.00 to each child.

I will be giving Blackhawk CC Grill our count on Friday. So far we have twenty people attending the Fall Banquet. If anyone else is interested in going please let me know by Friday, Nov. 4, 2022.

We will be hosting our club Christmas Party at Choza Mexican Grill at the Blackhawk Plaza on Saturday, Dec.10, 2022. I will put a flyer together and get that out to all members. It is on the calendar.

Rob – Our Adobe software program we pay monthly for is \$29. Dave M. our Web Director noted to us that he has been paying for his own copy to use for Club/Website business. We feel we should start paying him for that. We are looking into the program that we currently have to see if we can add him as a user. Mary will reach out to Dave and work with him to see if they can add him to the current program we are using, which Mary was able to obtain at a lower cost and hopefully the cost will be the same for a second user.

Dave is paying a lot more than what Mary is paying currently. Mary's subscription includes the entire package. Worst case scenario is if we add another user it could increase to \$59 per month. It will go up from \$29 to \$59. I will make a motion to the club to pay Dave for the fee. Motion seconded and approved. Moving forward we will cover as a club cost for 2 users for the software program. Dave also designs the club banner and needs illustrator for the club website etc..

Treasurer: George Robinson

NCCA Account, new deposits for yearly membership renewals and fall banquet.

George Robinson has resigned by written letter handed to the club President tonight. He is resigning from his position as Treasurer and as a club member.

Membership: Ken Coon

I will send Jim Watson a membership application tonight. He attended one of our car shows earlier this year and is here at tonight's meeting, so he has fulfilled his requirements and will be processed as a new member once his paperwork is received.

We have 4 couples outstanding for renewals, we have sent renewal reminder notices to them. As of Nov. 3, 2022, we have all members renewed except for 1 couple and 1 single.

(Comment was made by Tim Sullivan that we only had 48 members in our club.)

I am working on our November K.

Charitable Foundation: Hal & Madeline Briar

At our December meeting we will vote on which charities to give money to this year. I will pass around a worksheet that shows who we gave money to last year and we can vote on how much we want to give and to which charity at our next meeting. If anyone has another new charity to add to this list, please let us know. In December we will decide how much we will give to each charity.

Tim asked, did we agree to go back to our original amount of \$500 per charity a few months ago? Shirley will have to check her notes. I will have Shirley send a copy out to the club members of the list of charities, for club members to respond with who they would like to choose.

Historian: Herb Clore

I am working on getting the end of year video prepared to present to the club at the Fall Banquet Unfortunately, I will not be at the banquet, as I have family matters that I have to attend to back east. So, you guys have fun at the banquet. I apologize for any

last minute pictures/videos, (if I do not get them into the video) that you have sent in, but this will be a rush job since I have to fly out this weekend.

BMAL: Tim Sullivan

We didn't have enough people to run for all the offices that are vacant. We are missing the following: Publications & Sponsorship.

The board members that are doubling up and taking on the open positions "It is hard for them to do that".

We still have Rob Andersen- President, handling the position of Governor for NCCC.

Rob Andersen – New members Shawn and Cori Jonas are taking over Social Directors position. We are talking to new members and people that are interested in joining the club and hope they will be interested in taking on one of our empty positions. Our current members have been with the club for many years. I don't blame them for not wanting to step up and take on a position, as they have done years of helping this club in many positions. Problem is that many club members who have been part of the club for many years have held multiple positions and are not willing to take on an office now.

For now we are covering to get through until we can talk to more people to bring them on board.

Ken - When Jim Wells was BMAL, I helped with the nominations committee and we went thru all the members and contacted each of them regarding taking on one of the board positions. We had a lack of people who want to move forward. Now, Shawn Jonas is here tonight, Rob and I met him at our car show and at other car shows and talked to him and got him to join our club and he is taking over the Social position. We have also been going to cars and coffee events trying to recruit new members.

Rob - we need to find someone with that type of background to cover the positions that are vacant and being covered by other board members currently.

Ken – Regarding promoting the club to potential new members - We have contacted our son's neighbors who have corvette's and have talked to them about joining the club. I have dropped off an application and a magazine to both of them.

Mary – Going over the membership roster, we know who the active members are and who the non-active members are. They are pretty much loyal. They want to be a part of the club but are unable to help for various reasons.

Rob – Our members pay their dues and they show up every once in a while which is good.

Mary – Now that the Covid restrictions are lifted, we are going to more shows and cars and coffee events and communicating more with people who are corvette owners and who want to be involved.

Tim - I will see what I can do with Laguna Seca about having the corvettes do a pace lap. We had done this in the past.

Rob to Tim – Are you still working on getting a committee together for the updating of the ByLaws/Procedures Manual? Tim - We did it in 2021. Not due until 2023.

Rob - we have switched our insurance to NCCC and we need to update some of the wording in the Bylaws. The Bylaws were done in April of 2021. Tim would like to table this item and look at in January.

Ken – the Bylaws need to be updated now to reflect the changes, because we will need them to try and correct the issue with the IRS. We have to change the information that we are a 501c7 club and not a 501c3 club.

Rob – We will work on this and get a committee together. Tim asked what has to change in the By-Laws?

Public Relations: Open Position

Web Master: Dave Meccariello – Nothing to Report at this time.

General Discussion:

Side Note: A nomination was made by Michelle Ferretta, to nominate Wendy (McWilliams) for club President. The entire membership was silent. This was news to all of us. Michelle was told that it would have to be brought up to the membership via email.

The Board was shocked to hear of this. Wendy has not contacted anyone on the board regarding this. Wendy made no mention at the meeting that she was considering taking on President or any board position.

Tim Sullivan – BMAL had no knowledge of this.

The issue is that all nominations were to be made in Sept. 2022 and printed in the K in October 2022 and all members present at the meeting were to cast a secret ballot (according to our Bylaws) to vote for whoever has been nominated for the board position they are running against the current board member for.

After the meeting was adjourned it was discussed between the current President, VP Events, Secretary, Membership, and Historian, that none of us were contacted regarding Wendy wanting to take over as President.

Wendy McWilliams has let her membership lapse for 2 years and is not currently a member of NCCA. She has been a member in the past and will need to pay current dues and submit a renewal form to become a member of NCCA starting on Jan. 1, 2023. As long as she is an active member in the club she may run for an office in September of 2023.

THEREFORE: The nomination by Michelle Ferretta for Wendy to run for President of the club is not valid for our calendar year of 2023. Renewal form and fee/dues information has been forwarded to Wendy to fill out, and send in, to become a NCCA club member.

Re: Members and Board Positions

The following is being quoted from our current (April 2021) Bylaws and Procedures Manual

Page 2 ARTICLE III, SECTION B – DEFINITION AND BENEFITS AND RESTRICTIONS OF TYPES OF MEMBERSHIPS

1. Regular Membership
- A. Membership shall be one (1) or two (2) individuals; second individual being a spouse, partner or family member; limited to a maximum of two (2) individuals.
- B. Shall receive initial membership kit and one (1) copy of the NCCA's By-laws and Procedures Manual.
- C. Each member shall have one (1) vote for a total of two (2) votes maximum.
- D. Shall receive a printed version of the newsletter if they elect to pay the additional member dues associated with mailing the newsletter.
- E. May hold elective office.
- F. Shall receive member notification of future club events and other notices.

Page 5 ARTICLE VI, SECTION A – OFFICERS

12. Board Member-at-Large

E. Shall chair the Nominating Committee.

Page 7 & 8 ARTICLE IX, SECTION C – NOMINATING COMMITTEE

1. Purpose: The selection and nomination of candidates to fill the elective posts in the NCCA for the ensuing year. There may be more than one candidate per post.
2. Formation: This Committee will be formed by lot selection, from volunteers from members in attendance at the first scheduled General Business meeting in August.
3. Composition: This Committee shall be composed of the Board Member-at –Large, as Chairperson, and no more than four (4) members.
4. Duties: This Committee shall meet every year between August 1st and September 30th of the same year, in a closed meeting, at a time and place designated by the Chairperson. Any member contacting a Committee Member, requesting inclusion of their name on the ballot, must be included on the ballot.
5. The committee Chairperson shall present the list of all nominations at the October General Business meeting. Additional nominations shall be open from the floor and those nominated shall also be placed on the ballot. Nominees shall be published in the NCCA newsletter (K) prior to the November General Business Meeting.

Old Business: Per Herb – The K – Are we going completely digital for the K publication or not? Per Mary and Rob – We will run as we have been thru the end of this year and in 2023 we will make a decision on this.

New Business: None

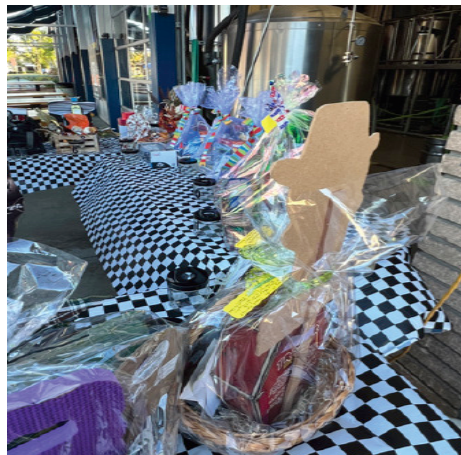

Shirley Smith C4 - First Place



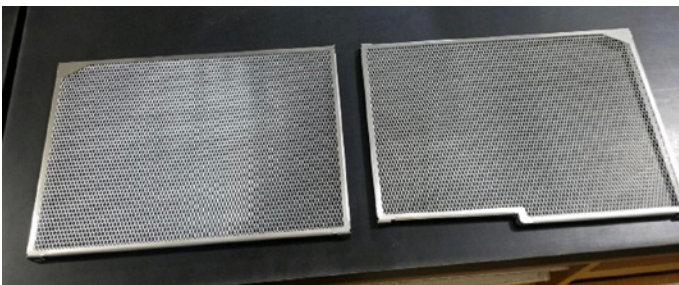
TPS MOTORSPORTS

The new C8 Corvette is an amazing car with its new mid-engine format, traction control, and host of tech features. For the \$76K I paid for my 2LT car from Abel Chevrolet there is no better new performance car which can be purchased off a dealer show room floor. The great thing about new models of cars is there are new upgrades and mods which are available! I can't leave a car stock. 😊

My car has a host of upgrades but today we're going to focus on the install of the Vertical Doors Lambo Door Kit. The "Lambo Doors" was made popular in the early 80's by the Lamborghini Countach. The install of the kit is VERY labor intensive and requires the entire front clip to be removed which includes the front fenders, bumper, and head lights. The process takes about 2-3 days and costs \$4599 for parts and labor. We offer lifetime warranty on the labor for the door kit if it ever needs adjustment. After the doors are installed, you can open them normally OR as a Lambo Door.

While the front bumper is off, I would HIGHLY recommend installing a set of our TPS C8 Radiator Screens. The C8 has 2 massive openings in the front of the bumper which is great for air flow to the radiator BUT the issue it creates is it leaves the radiator exposed to being damaged. Look at any stock C8 without radiator screens and you will see the car's radiator has damage to them. Our screens retail for \$299, have a lifetime warranty, made in the USA, and covers the entire radiators for protection compared to others on the market.

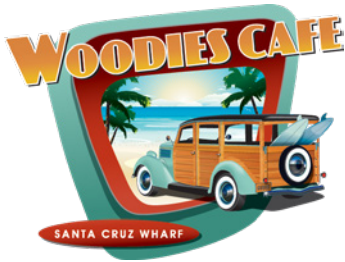

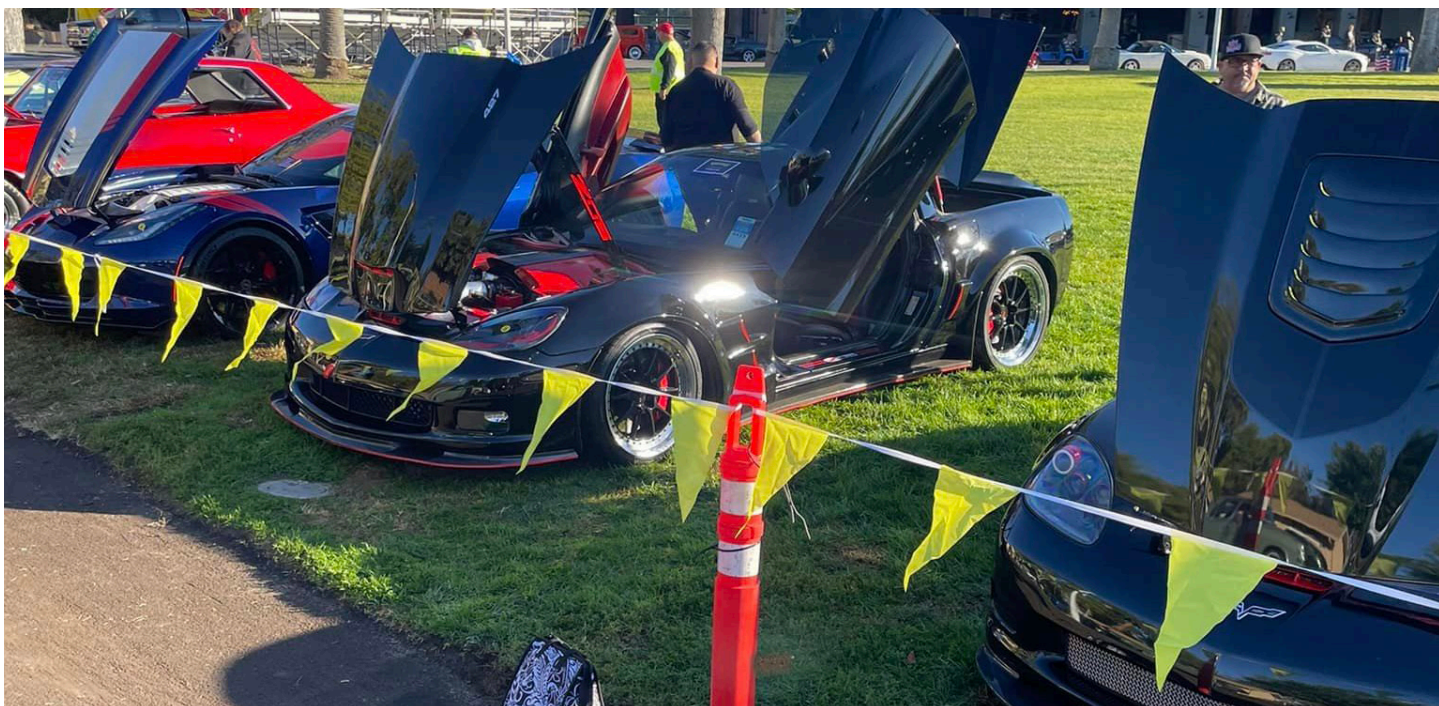
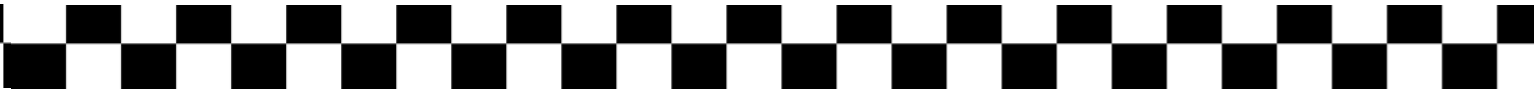
